## ***MEMBERSHIP AGREEMENT, GENERAL RULES OF CONDUCT, & PRICE LIST FOR 2010-2011 SEASON***

Membership with Colorado WINGSPORT, hereafter referred to as WINGSPORT, is conditional upon payment of annual dues, acceptance of Applicant by the Management, and agreement to the following terms:

1. Member shall abide by Colorado State Law pertaining to Commercial Wildlife Parks (CWP). Specifically:
  - a.) member shall hunt only within the boundary of the designated CWP.
  - b.) member shall only be exempted from Colorado State law in the following areas:
    - 1) *Season*: shall be September 1 through March 31.
    - 2) *Bag limit*: is unlimited by number or sex for the species of birds released.
    - 3) *License*: no individual small game license is required while hunting on a CWP for released species.

**All other Colorado State laws apply.**

2. **GUEST POLICY**. Each of your hunting guests are allowed guest privileges for **two** visits only, and must purchase a standard release of birds at the member price rate.
3. **RESERVATIONS** are required prior to the hunting date. Kindly allow 24 to 48 hours notice to schedule a hunt. Cancellations must be made a minimum of 24 hours prior to your scheduled hunt time. If notice of cancellation is not received, then you will be charged the full amount of the hunt.
4. Members shall be responsible for any damage to property caused by members or their guests.
5. WINGSPORT and landowners of leased property shall not be held liable for accidents and/or injuries incurred by members or guests while the same are on any CWP operated by WINGSPORT.
6. Only the species of game birds released by WINGSPORT may be hunted by the member or his guests. No other species of wildlife may be hunted or in any way harmed or harassed.
7. Members shall report numbers and species of birds harvested to the management of WINGSPORT as directed at the time of hunt.
8. Littering, bird cleaning, alcohol or drug consumption before and during hunting, and intoxication are strictly prohibited while on any WINGSPORT property.
9. The term of this membership is from September 1, 2010 to March 31, 2011.
10. Violation of any of these articles of agreement is cause for forfeiture of membership privileges and membership dues.
